Karin and Ross had planned on teaching English in China over the summer, and even had most of their support in place, but it was not to be. Karin was especially saddened by the death of our 13 year old cat, Buster, who had been in failing health since his sister died last year.

The other half of the dynamic duo, the boy wonder with a bald spot, continues the family tradition of over-commitment. In addition to a heavy clinic schedule with Group Health, he teaches Junior Church, does occasional speaking on unhealthy influences in American culture, facilitates the Drama program at church, organizes meetings, helps the girls with homework, repairs the house, writes letters to every editor in the five-state area and still manages to find time to get into unrelated trouble. Just days before the drafting of this present epistle, he sat before the State Medical Board to answer charges of discussing religious matters in a medical setting. The complaint was made by an unidentified medical professional. The family was very pleased with the care, but the Board took the opportunity to look for evidence of medical mismanagement. Despite the distance to our home church Jason has been coming every Sunday and is a good contributor to the discussion in the young adults class.

Stacy is a 10th grade math-o-phobic student at South High School who is getting an "A" in geometry, not to mention Chinese, and a few other subjects. She was on Summer Mission Team last summer at Camp Shamineau, doing everything from washing dishes to junior counseling. She studies hard and still finds time for dance and music. She is currently in "The City Children's Nutcracker" and danced at "Music Minnesota" in July. A frequent soloist at our home church, she has also been selected to travel with the well known "Continentals" this summer, praising the Lord through music and dance. In addition to touring the USA, they will spend time in Holland, Germany and the Czech Republic, all for a total of three months. Stacy has a deep concern for her classmates and they often share their struggles and problems with her. She is not afraid to speak out on issues of importance, despite pressure to be politically correct. Most of all, she shares about the peace and love that only Jesus can give.

Part of the family will travel to Tucson over Christmas to visit our most southerly relations, Tim and Denise Falck. Ross and Karin went to an ethics conference in Illinois in the spring. Maybe all the miles add up to a trip to China and maybe we will get there again.
